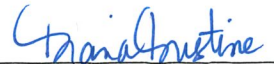


MINUTES

REORGANIZATION MEETING OF JANUARY 2, 2024 – 6:30 p.m.

All Meetings Recorded

	Mayor Martha Long, Councilman Howie Crawford, Councilwoman Mary Long, Councilwoman Pam Griffin, Councilwoman Kathie McMunn, and Secretary Diana Durstine were present.
OPEN MEETING/PLEDGE	The meeting was opened, and the Pledge of Allegiance was led by Mayor Long.
OATH OF OFFICE	Mayor Long administered the Oath of Office to newly elected council member Kathie McMunn.
ELECTION OF COUNCIL PRESIDENT	Councilwoman McMunn nominated Councilman Crawford. By unanimous voice vote, Howie Crawford becomes the Council President.
ELECTION OF COUNCIL VICE-PRESIDENT	Councilwoman Griffin nominated Councilwoman Long. By unanimous voice vote, Mary Long becomes the Council Vice-President.
	At this time, the meeting was turned over to Council President Howie Crawford.
COUNCIL COMMITTEE APPOINTMENTS	President Crawford moved on to nominations for Committee appointments.
<i>Management/Finance</i>	Councilwoman Long was nominated by Councilwoman McMunn, second by Councilwoman Griffin and carried unanimously.
<i>Public Works Streets/Properties</i>	President Crawford was nominated by Councilwoman McMunn, second by Councilwoman Griffin and carried unanimously.
<i>Recycling/Solid Waste</i>	Councilwoman Griffin was nominated by Councilwoman McMunn, second by Vice-President Long and carried unanimously.
<i>Recreation Board</i>	President Crawford was nominated by Vice-President Long, second by Councilwoman McMunn and carried unanimously. Vice-President Long suggested Councilman Rigby be considered when he is back.
<i>Comments & Concerns</i>	Councilwoman McMunn was nominated by Vice-President Long, second by Councilwoman Griffin and carried unanimously.
NEW BUSINESS	Vice-President Long confirmed there were no current concerns that needed to be addressed. There was a short discussion regarding the timing of recycling collection and residents not paying for garbage pick-up wanting spring clean-up collection back.
ADJOURNMENT	Motion by Councilwoman McMunn, second by Councilwoman Griffin and carried unanimously to adjourn the meeting at 6:43 p.m.
